
- Ministries



Public Sector's Accommodation Programme Current Status

- KED has already engaged PPP Advisors
 - JV of Hypovereinsbank, Commercial Bank & Lambert Smith Hampton as PPP advisors together with Currie & Brown and ADK as technical advisors
- Currently concluding Strategic Plan
 - Sets the basis for the implementation of the accommodation programme
 - Analyses project data
 - Identifies conditions, methodology and end-user's requirements
- Has commenced execution of "fast track" projects
 - Two of these are already approved and in implementation mode
 - Two more contracts for the Hellenic Police are being prepared for submission to the PPP Special Secretariat


Financial Advisor's Timetable



Ministry of Public Order

- Fire Department 7 fire stations
 - Involves seven fire stations throughout Greece
 (Thessaloniki, Lefkada, Messollogi, Gargaliani, Veria, Giannitsa, Alexandroupoli)
 - 8.250m² of above-ground construction
 - Budget estimated at about €32 million
 - Have been approved by the PPP Special Secretariat
 - Currently preparing the Output Specification and carrying out Technical and Legal Due Diligence
 - Expected to be the first Greek PPP project to be launched)

Duration of PPP Agreement: 15 years

Budget : €36 million

Ministry of Public Order

- Hellenic Police Force
 - 27 Buildings of various sizes
 - 40.000 m² of above-ground construction
 - Budget estimated at about €117 million
 - Currently preparing Strategic Business Case
 - PPP proposal to be submitted this month to PPP Special Secretariat for approval
 - Technical Due Diligence in progress

Ministry of Public Order

- Hellenic Police National Headquarters
 - Currently preparing documentation for submission for approval to the PPP Special Secretariat
 - Technical aspects of the project require extensive work
 - Project will consist of more than 20.000 m² of office space plus underground parking and ancillary spaces.
 - Project of the Police Cultural Centre in the former
 Police Academy is closely related

Main Issues Requiring Market Feedback


- Attractiveness of the projects to international PPP Investors
- Readiness of the Greek market for the projects
- Critical Mass required for each contract
- Geographical Dispersion of the Projects
- Outsourcing of Facilities Management
- Optimal Grouping of the Projects
- Optimal Risk Allocation
- Extraction of "value for money"

Criteria for the selection of bids procedure

- Characteristics of the project on Tender (technical, legal & financial complexity)
- Securing the participation of bidders
- Securing the bidder's competence
 - Construction
 - Operation and Maintenance during project life-cycle
- Obstacles Unanticipated Delays
 - Legal issues, Procurement Process Issues etc.
 - Likelihood Objections by Tenderers
- Process Transparency
- Securing of "value for money"
