

# Smooth and transparent tender process

- Tenders in accordance with EU legislation
- Restricted procedure is used (2 phases)
  - Phase I EoI : Pre selection of bidders
  - Phase 2 Submission of Final offers : Input and detailed output specifications are provided to pre selected bidders
- Pre selection and selection based solely on objective criteria
- Minimized bidding costs for contractors
- Minimized risks for legal challenges
